- Results were tabulated to allow comparison to the 2009 survey results. However, more programs responded this year (N=38) than last year (N=35) and the comparison is not “one-to-one”.

Programs Responding

- 38 (35) programs responded
 - CAMPEP-accredited 32 (23)
 - not CAMPEP-accredited 6 (12)

- US 33 (30)
- Canada 4 (5)
- Ireland 1 (0)

- 34 (30) therapy physics / 4 (5) imaging physics
